CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LUCKIAMUTE VALLEY FARMS LLC  
 PO BOX 607  
 INDEPENDENCE OR 97351

confirms the right to use the waters of the LITTLE LUCKIAMUTE RIVER, a tributary of LUCKIAMUTE RIVER, for the purpose of IRRIGATION of 70.5 ACRES.

This right was perfected under Permit S-32204. The date of priority is MARCH 13, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.88 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The place of use is as follows:


**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for non-completed change in point of diversion approved by an order of the Water Resources Director enter August 26, 1993, at Special Order Volume 47, Page 317, approving Transfer Application T-6533 and supersedes Certificate 41885, State Record of Water Right Certificates.

The right to the use of the water for the purpose aforesaid is restricted to the lands or place of use herein described.
