CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEORGETTE L. COPELAND
7900 NE MILL CREEK ROAD
PRINEVILLE, OR 97754

confirms the right to use the waters of MILL CREEK, a tributary of CROOKED RIVER for the purpose of the IRRIGATION of 8.0 ACRES of LAND, and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is 1897.

The points of diversion are located as follows:

The amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for STOCK USE and one-tenth CUBIC FOOT PER SECOND for irrigation, the total quantity being limited to four acre feet per acre during each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of diversion (POD C, POD D, POD L), together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original point of diversion are located as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted from POD L.

When required by the Department, the water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted at POD's C & D. The types and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface water source as the original point of diversion.


The water user shall maintain and operate fish screening as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the diversion.

Notwithstanding that Oregon Department of Fish and Wildlife has made a determination by-pass devices are not necessary at this time, the water user may be required in the future to install, maintain, and operate by-pass devices to prevent fish from entering the diversion, and to provide adequate upstream and downstream passage for fish.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE, ADDITIONAL POINTS OF DIVERSION, and PARTIAL CANCELLATION OF WATER RIGHT approved by an order of the Water Resources Director entered July 21, 2003 at Special Order Volume 57, Page 1100, approving Transfer Application T-8732, and corrected by Special Order Volume 57 page 1307 on August 12, 2003, and supersedes Certificate 635, State Record of Water Right Certificates.
