CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEORGETTE L. COPELAND 7900 NE MILL CREEK ROAD PRINEVILLE, OR 97754 SUPERSEDED BY CERT. NO. 89446

confirms the right to use the waters of MILL CREEK, tributary to OCHOCO CREEK for SUPPLEMENTAL IRRIGATION of 180.7 ACRES.

This right was perfected under permit S-23710. The date of priority is JUNE 22, 1955. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for the purposes and shall not exceed 2.26 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of diversion (POD C, D & L) together with that diverted at the original points of diversion, shall not exceed the quantity of water available from the original points of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted from POD L.

When required by the Department, the water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted at POD's C & D. The types and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface water source as the original point of diversion.

The water user shall maintain and operate fish screening as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the diversion.

Notwithstanding that Oregon Department of Fish and Wildlife has made a determination by-pass devices are not necessary at this time, the water user may be required in the future to install, maintain, and operate by-pass devices to prevent fish from entering the diversion, and to provide adequate upstream and downstream passage for fish.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE and ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered July 21, 2003 at Special Order Volume 57, Page 1100, approving Transfer Application T-8732 and corrected by Special Order 57, page 1307 on August 12, 2003, and, supersedes Certificate 23717, State Record of Water Right Certificates.
