CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of APPLEGATE RIVER, a tributary of ROGUE RIVER for the purpose of IRRIGATION OF 32.4 ACRES, DOMESTIC USE AND STOCK USE IN TRACT 1 AND MINING IN TRACT 2.

This right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is entered of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The priority of the right thereby confirmed dates from 1866 for TRACT 1 and 1858 for TRACT 2.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.81 CUBIC FOOT PER SECOND FOR TRACT 1 AND 9.50 CFS FOR TRACT 2.
