CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

AUGUST AND ANNAMARIA PICOLLO 637 BUTTE FALLS HWY PROSPECT OR 97536

confirms the right to use the waters of AN UNNAMED STREAM WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY TO BE MADE UP BY APPROPRIATION FROM RED BLANKET CREEK, both tributaries of SOUTH FORK ROGUE RIVER, for IRRIGATION of 4.1 ACRES.

This right was perfected under Permit S-32987. The date of priority is AUGUST 25, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.05 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 13, 2002, at Special Order Volume 56, Page 2200, approving Transfer Application 8106, and together with Certificate 79752, supercedes Certificate 56559, State record of Water Right Certificates.
