CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

W. S. SKINNER JORDAN VALLEY, OR

confirms the right to use the waters of JORDAN CREEK FOR TRACTS NOS. 2, 3, 4; JORDAN CREEK WILLOW AND RYE GRASS LANDS FOR TRACT NO. 5; COW CREEK FOR TRACT NO. 6, a tributary of the OWYHEE RIVER for IRRIGATION. The dates of priority are: 1868 FOR TRACT NO. 2; 1869 FOR TRACT NO. 3; 1901 FOR TRACT NO. 4; TRACT NO. 5 WITHOUT DATE OF PRIORITY; 1908 FOR TRACT NO. 6.

The amount of water to which this right is entitled, for the purposes aforesaid, is limited to an amount actually used beneficially for said purposes.

A description of the place of use under the right and to which this right is appurtenant, is as follows:

Tracts Nos. 2, 3, 4 and 6: for irrigation of the following lands, and shall not exceed 2.0 acre feet per acre prior to June 1st, and ½ acre foot per acre during any calendar month after June 1st, of each irrigation season from April 1st to October 15th.

This certificate corrects a scrivener's error in Certificate 89238. The irrigation season was written as going to October 5th instead of October 15th. This certificate supersedes Certificate 89238.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
