CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RANDY MANTUA  
 PO BOX 1  
 BODEGA BAY CA 94923

confirms the right to use the waters of TWO WELLS in the GOOSE LAKE BASIN for IRRIGATION OF 440.1 ACRES; BEING 102.6 ACRES PRIMARY AND 337.5 ACRES SUPPLEMENTAL.

This right was perfected under Permit G-9165. The date of priority is NOVEMBER 20, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.14 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that the amount of water diverted from the channel of THOMAS CREEK shall not exceed the amount by which the flow of THOMAS CREEK is increased above the natural flow by the operation of the well.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The user shall install and maintain a weir, meter, or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The quantity of water diverted at the new point of appropriation (well), together with the quantity of diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.


The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate is issued to confirm a change in AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JUNE 23, 1999, at Special Order Volume 53, Page 905, approving Transfer Application 8241, and supercedes Certificate 75601, State record of Water Right Certificates.
