confirms the right to use the waters of A WELL, a tributary of MISSION CREEK (Willamette River) for MUNICIPAL USES.

This right was perfected under Permit G-4047. The date of priority is SEPTEMBER 11, 1968. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.24 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of appropriation is located as follows:

This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for a non-completed change in point of appropriation approved by an order of the Water Resources Director entered November 19, 2002, at Special Order Volume 56, Pages 2060-2062, approving Transfer Application T-9095 and supersedes Certificate 40213, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
