CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL 14 (HARN 129), tributary of EAST BRANCH FOLEY SLOUGH (SILVIES RIVER) for IRRIGATION of 8.2 ACRES and SUPPLEMENTAL IRRIGATION of 26 ACRES.

This right was perfected under permit G-1808. The date of priority is APRIL 3, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.43 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
