confirms the right to use the waters of TWO WELLS within the PUDDING RIVER BASIN for IRRIGATION of 204.1 ACRES.

This right was perfected under Permit G-2720. The date of priority is JULY 29, 1964. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.45 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of appropriation (well), together with that diverted at the old point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.

When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered OCTOBER 24, 1996, at Special Order Volume 50, Page 777, approving Transfer Application 6903, supercedes Certificate 36211, State record of Water Right Certificates.
