If the Director notifies the water user to install a totalizing flow meter or other measuring device, the water user shall install such device specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meter or measuring device in good working order and shall allow the Watermaster access to the meter or measuring device.

The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water available at the original point of appropriation.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described herein.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered December 29, 2009, at Special Order Volume 79, Page 1270, approving Transfer Application T-10958, and supersedes Certificate 34373, State Record of Water Right Certificates.
