 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GRAY & COMPANY
 P.O. BOX 218
 FOREST GROVE, OREGON

confirms the right to use the waters of a WELL a tributary of WILLAMETTE RIVER for the purpose of IRRIGATION of 20.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 30.7 ACRES.

This right was perfected under Permit G-3154. The date of priority is JANUARY 31, 1966. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used, and shall not exceed 0.64 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


