 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SLEGERS FARMS, INC.
 ROUTE 1, BOX 220
 DAYTON, OREGON 97114

confirms the right to use the waters of SLEGERS SEWAGE LAGOON CONSTRUCTED UNDER PERMIT R-6572, a tributary of the WILLAMETTE RIVER, for the purpose of SUPPLEMENTAL IRRIGATION of 148.6 ACRES.

This right has been perfected under Permit S-41510. The date of priority is APRIL 26, 1977. This right is limited to 35.0 ACRE-FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the lagoon.

The point of diversion on the lagoon is located as follows:

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 2.5 acre-feet (or its equivalent) for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:



This certificate describes that portion of the water right confirmed by Certificate 65623, State Record of Water Right Certificates, diminished by the provisions of an order of the Water Resources Director entered August 20, 2014, approving Transfer Application T-11559.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
