CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of Locey Well, tributary of Willow Creek, tributary of Malheur River for the purpose of irrigation of 33.5 acres.

This right was perfected under Permit No. U-629. The date of priority is MARCH 30, 1954. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.42 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year. This right is issued subject to the terms and conditions of a stipulation and agreement recorded on Pages 830-832, Volume 3, Miscellaneous Records of the State Engineer.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the purpose aforesaid is restricted to the lands or place of use herein described.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
