 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES A. WOOD AND ALBERT STARR
 3181 SW SAM JACKSON PARK RD
 PORTLAND, OR 97201

confirms the right to use the waters of TWO WELLS, tributary of BUTTER CREEK for the purpose of IRRIGATION of 263.2 ACRES.

This right was perfected under Permit G-2952. The date of priority is JUNE 19, 1958. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.3 CUBIC FEET PER SECOND, BEING 1.65 CFS FROM EACH WELL, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
