CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MUDDY CREEKS IRRIGATION PROJECT 32255 BOWERS DR HARRISBURG OR 97446

confirms the right to use the waters of MUDDY CREEK and MCKENZIE RIVER, tributaries of the WILLAMETTE RIVER, for IRRIGATION OF 181.5 ACRES.

This right was perfected under Permit S-17510. The date of priority is FEBRUARY 9, 1939. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.27 CUBIC FEET PER SECOND (CFS), being further limited to 0.92 CFS for lands served by Muddy Creek (New T-7163) diversion (or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface source as the original point of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 29, 2000, at Special Order Volume 54, Page 203, approving Transfer Application 7163, and together with Certificate 76399, supercedes Certificate 75226, State record of Water Right Certificates.
