CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of FIVEMILE CREEK (for Tract #1) AND EIGHTMILE CREEK (for Tract #2),  
TRIBUTARIES OF FIFTEENMILE CREEK for IRRIGATION OF 63.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 406. The date of priority is 1878 FOR TRACT #1 AND 1875 FOR TRACT #2.

The amount of water to which such right is entitled, for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed three acre feet per acre in any irrigation season.

The points of diversion are located as follows:

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices.

That the pumping plant and related works shall include a weir or other suitable device for measuring the water to which the water user is entitled.

That the plans of the weir or other suitable device be approved by the Watermaster and that the weir or measuring device be installed under the general supervision of the Watermaster.

The quantity of water diverted at the new points of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available from the original points of diversion.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered July 3, 1961, at Special Order Volume 11, Page 221, approving Transfer Application S-136, supercedes Certificate 5652, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in said decree.
