CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOST AND BOULDER DITCH COMPANY
P.O. BOX 191
WAMIC, OREGON 97063

confirms the right to use the waters of LOST CREEK, BOULDER CREEK, AND FOREST CREEK, tributaries to WHITE RIVER for IRRIGATION of 1396.7 acres and SUPPLEMENTAL IRRIGATION of 57.9 acres.

This right was perfected under Permit S-47709.

The date of priority is MARCH 10, 1980, for 35.93 Cubic Feet per Second (CFS), and MAY 7, 1981 for 0.37 CFS. This right is limited to 36.3 CFS, being 34.9 CFS for primary irrigation, and 1.4 cfs for supplemental irrigation, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located:

Lost Creek: 1310 FEET NORTH AND 1730 FEET EAST FROM SW CORNER, SECTION 26, being within the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 26, Township 4 South, Range 10 East, W.M.

Boulder Creek: 2010 FEET NORTH AND 180 FEET WEST FROM SE CORNER, SECTION 27, being within the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 27, Township 4 South, Range 10 East, W.M.

Forest Creek: 195 FEET NORTH AND 256 FEET EAST FROM SW CORNER, SECTION 27, being within the SW $\frac{1}{4}$ SW $\frac{1}{4}$ SECTION 27, Township 4 South, Range 10 East, W.M.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre during the irrigation season of each year.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


