confirms the right to use the waters of WILLOW VALLEY RESERVOIR, tributary to Lost River and Tule Lake for SUPPLEMENTAL IRRIGATION of 1835.2 ACRES.

This right was perfected under Permit S-27387.

The date of priority is JULY 3, 1961.

This right is limited to 2038 ACRE-FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source. The storage reservoir is to be enlarged under permit R-2631.

The point of diversion is located:

Willow Valley Reservoir: 50 FEET SOUTH AND 550 FEET EAST FROM NW CORNER, SECTION 19, being within LOT 1 (NW 1/4 NW 1/4) of Section 19, Township 41 South, Range 14.5 East, W.M.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 3 acre-feet per acre during the irrigation season of each year.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
