confirms the right to use the waters of NORTH FORK CROOKED RIVER, BRUSH CREEK, JOHNSON CREEK, CRAM CREEK, HOWARD CREEK, INDIAN CREEK AND TRIBUTARY (SHADY CREEK), STUMP CREEK, FOX CREEK, ELLIOT CREEK AND TRIBUTARY (EAST ELLIOT CREEK), ALLEN CREEK, SPRINGS AND SEEPAGE AREAS AND PETERSON CREEK, tributaries of CROOKED RIVER, for IRRIGATION OF 4292.9 ACRES.

This right was perfected under Permit 24774. The date of priority is JUNE 30, 1955. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 96.76 CUBIC FEET PER SECOND (CFS); BEING 12.99 CFS FROM NORTH FORK CROOKED RIVER FOR THE IRRIGATION OF 519.8 ACRES, 5.0 CFS FROM BRUSH CREEK FOR THE IRRIGATION OF 292.2 ACRES, 9.56 CFS FROM JOHNSON CREEK FOR THE IRRIGATION OF 382.5 ACRES, 8.18 CFS FROM CRAM CREEK FOR THE IRRIGATION OF 327.2 ACRES, 10.90 CFS FROM HOWARD CREEK FOR THE IRRIGATION OF 436.1 ACRES, 4.76 CFS FROM INDIAN CREEK AND TRIBUTARY (SHADY CREEK) FOR THE IRRIGATION OF 190.5 ACRES, 0.69 CFS FROM STUMP CREEK FOR THE IRRIGATION OF 27.4 ACRES, 1.63 CFS FROM FOX CREEK FOR THE IRRIGATION OF 65.3 ACRES, 10.00 CFS FROM ELLIOT CREEK AND TRIBUTARY (EAST ELLIOT CREEK) FOR THE IRRIGATION OF 730.1 ACRES, 28.64 CFS FROM ALLEN CREEK FOR THE IRRIGATION OF 1145.5 ACRES, 0.24 CFS FROM SPRINGS AND SEEPAGE AREAS FOR IRRIGATION OF 9.4 ACRES AND 4.17 CFS FROM PETERSON CREEK FOR IRRIGATION OF 166.9 ACRES, or its equivalent in case of rotation, measured at the points of diversion from the sources.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.
