CERTIFICATE OF WATER RIGHT

This is to Certify, That **ORCHARDS WATER COMPANY** **SUPERSEDED** **45353**
CERTIFICATE NO. _____
of **Brogan**, State of **Oregon** has a right to the use of

the waters of Willow Creek, stored in Reservoir No. 3, and Black Creek and Pole Creek, stored in Reservoir No. 1, of said Company; also the direct flow thereof; for the purpose of Irrigation;

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for **Malheur** County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume ⁹ at page ³¹¹; that the priority of the right thereby confirmed dates from **Apr. 7, 1908** as to the waters of Willow Creek, and **May 29, 1907** as to the waters of Black and Pole Creeks;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **two acre feet per acre** during any irrigation season.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Said rights are subject to all other conditions and limitations contained in said decree.

NOTE: This certificate supersedes that certain water right certificate issued August 13, 1927, and recorded in State Record of Water Right Certificates Vol. 7, Page 7511. The foregoing tabulation describes the lands to which this right is appurtenant, taking into consideration certain changes in place of use of water approved by the State Engineer by Special Order dated June 4, 1928, and recorded in Vol. 1, Page 518.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
