CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of COLUMBIA RIVER, tributary of PACIFIC OCEAN for IRRIGATION of 46.9 ACRES.

This right was perfected under Permit S-36940. The date of priority is JUNE 29, 1973. The amount of water to which this right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.09 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under this right hereby confirmed, and to which such right is appurtenant, is as follows:

The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.


The right to the use of the water for the purpose aforesaid is restricted to the lands or place of use herein described.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered January 24, 2013, at Special Order Volume 88, Page 1200, approving Transfer Application T-11227, and together with Certificates 88116 and 88117, 89665 supersedes Certificate 52082, State Record of Water Right Certificates.
