confirms the right to use the waters of the COLUMBIA RIVER, a tributary of the PACIFIC OCEAN, for IRRIGATION of 78.1 ACRES.

This right was perfected under Permit S-36940. The date of priority is JUNE 29, 1973 plus one minute. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.83 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
