# CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL FOR THE PURPOSE OF INDUSTRIAL USES TO INCLUDE WASHING OF BUILDING FLOORS AND OUTSIDE PAVED AREAS FOR CLEANING AND DUST CONTROL, WETTING AREAS FOR FIRE PREVENTION AND WATER FOR DRINKING AND SANITARY FACILITIES.

This right was perfected under Permit G-10775. The date of priority is DECEMBER 24, 1986, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 21.0 GALLONS PER MINUTE measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

# NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.
