CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENNETH W MILES
DELMA D MILES

confirms the right to use the waters of MILES WELL, tributary to POWDER RIVER (SNAKE RIVER) for IRRIGATION of 116.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 217.9 ACRES.

This right was perfected under Permit G-2886. The date of priority is APRIL 23, 1965. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.25 CUBIC FEET PER SECOND (CFS), FURTHER LIMITED TO 1.1 CFS FOR IRRIGATION AND 2.15 CFS FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to describe the water right following an Order of Diminution issued on December 20, 1984 at Volume 38, Page 550, and the Order of Cancellation of a Portion of a Water Right issued June 27, 1985 at Volume 39, Page 231, and supercedes Certificate 37874, State record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
