## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ADA WESTON RT. 2 BOX 342 GRANTS PASS, OR 97526

confirms the right to use the waters of DUTCHER CREEK, a tributary of the ROGUE RIVER for SUPPLEMENTAL IRRIGATION of 10.0 ACRES.

This right was perfected under Permit S-13860. The date of priority is AUGUST 12, 1939. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.13 CUBIC FOOT PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cfs, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
