CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DEPARTMENT OF VETERANS AFFAIRS DVA #P-48589 700 SUMMER ST. NE SALEM, OR 97310-1201

confirms the right to use the waters of an UNNAMED DRAINAGEWAY AND MOHNEY RESERVOIR, CONSTRUCTED UNDER PERMIT R-6397 AND ENLARGED UNDER PERMIT R-10506, tributaries of SOUTH YAMHILL RIVER for IRRIGATION of 5.8 acres and SUPPLEMENTAL IRRIGATION of 17.6 acres.

This right was perfected under Permit S-49379. The date of priority is MAY 15, 1985. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.07 CUBIC FOOT PER SECOND (cfs) and STORED WATER ONLY ON THE LANDS DESCRIBED AS SUPPLEMENTAL, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cfs per acre from DIRECT FLOW, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
