## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO LARRY AND JUDY GROSS 8105 RED PRAIRIE ROAD SHERIDAN, OR 97378

confirms the right to use the waters of an UNNAMED DRAINAGEWAY AND MOHNEY RESERVOIR, CONSTRUCTED UNDER PERMIT R-6397, a tributary of SOUTH YAMHILL RIVER for IRRIGATION of 17.8 acres.

This right was perfected under Permit S-39938. The date of priority is AUGUST 25, 1975. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.22 CUBIC FOOT PER SECOND (cfs) or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cfs per acre from DIRECT FLOW, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage FROM RESERVOIR CONSTRUCTED UNDER Permit R-6397. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
