confirms the right to use the waters of WHYCHUS CREEK (formerly known as SQUAW CREEK), a tributary to the DESCHUTES RIVER for IRRIGATION of 18.0 ACRES AND DOMESTIC.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1 at Page 120. The date of priority is 1880.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.445 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.
