## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WHYCHUS CREEK (formerly known as SQUAW CREEK), a tributary to the DESCHUTES RIVER for IRRIGATION of 40.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1 at Page 471. The date of priority is 1895.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.624 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:
