 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THE STATE OF OREGON
 WATER RESOURCES DEPARTMENT

confirms the right to use the waters of WHYCHUS CREEK, a tributary of the DESCHUTES RIVER, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat, and other ecological values.

This right was perfected under Permit E-176 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, and made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1 at page 284. The date of priority is OCTOBER 7, 1912.

The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.042 CUBIC FOOT PER SECOND (CFS), being 0.042 CFS for Reach 1 and 0.032 CFS for Reach 2, from April 1 through October 31, or such other time as Three Sisters Irrigation District is diverting water for a beneficial use under this right.

The descriptions of the stream reaches in which flows are to be maintained are as follows:

REACH 1: (0.042 CFS)

From the location of the diversion previously authorized under Certificate 85388, located at approximately River Mile 23.75:

To River Mile 19.2

REACH 2: (0.032 CFS)

From River Mile 19.2 to the mouth of Whychus Creek at the confluence with the Deschutes River, at River Mile 0.0.

The instream right established by this allocation of conserved water shall be additive to the instream water rights established pursuant to ORS 537.341, ORS 537.346, ORS 537.348, or ORS 537.470, unless otherwise specified by a subsequent order establishing a new instream water right.

This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume ~~95~~, Page ~~68-88~~. Approving Allocation of Conserved Water Application CW-71.

The right is subject to all other terms and conditions of Certificate 85388, and any related decree.
