confirms the right to use the waters of WHYCHUS CREEK (formerly known as SQUAW CREEK), a tributary to the DESCHUTES RIVER for IRRIGATION of 34.1 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1 at Page 471. The date of priority is 1900.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.682 CUBIC FOOT PER SECOND (if available at the original point of diversion being within the NWSW, SECTION 9, TOWNSHIP 15 SOUTH, RANGE 10 EAST, W.M.; 910 FEET SOUTH AND 160 FEET EAST FROM THE W ¼ CORNER OF SECTION 9), or its equivalent in case of rotation, measured at the point of diversion.
