confirms the right to use the waters of TUCKER CREEK, a tributary of POWDER RIVER for IRRIGATION OF 123.3 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR in Volume 6, at Page 291. The date of priority is 1876.

The use is limited to 3.08 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:
