CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO WELLS for the purpose of PRIMARY IRRIGATION of 58.3 ACRES and SUPPLEMENTAL IRRIGATION of 71.4 ACRES.

This right was perfected under Permit U-176. The date of priority is FEBRUARY 11, 1946. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.43 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-TWENTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be limited to a diversion of not to exceed 1½ acre feet per acre for each acre irrigated in any 30-day period prior to June 1st, 1.0 acre foot per acre for each acre irrigated in any 30-day period after June 1st and shall be further limited to a total diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


Measurement, recording and reporting conditions:

- A. The water user shall maintain the meters or measuring devices in good working order.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The right to the use of the water for the purposes aforesaid is restricted to the lands and place of use herein described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered July 21, 2014, at Special Order Volume 92, Page 1033, approving Transfer Application T-11676, and together with Certificate 89324, supersedes Certificate 26367, State Record of Water Right Certificates.
