CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of COTTONWOOD CREEK AND COTTONWOOD RESERVOIR CONSTRUCTED UNDER PERMIT R-4699, a tributary of MIDDLE FORK MALHUER RIVER, for SUPPLEMENTAL IRRIGATION of 125.0 ACRES.

This right was perfected under Permit S-31115. The date of priority is JUNE 8, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.59 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Measurement, recording and reporting conditions:


- A. The water user shall maintain the meters or measuring devices in good working order.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The use of water is subject to the terms and conditions of an Order of the State Engineer recorded in Special Order Records Volume 14, Page 216 through 226, Special Order Records of the Water Resources Department.

The right to the use of the water for the above purpose is restricted to beneficial use on place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for instream flows.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered July 21, 2014, at Special Order Volume 92, Page 1033, approving Transfer Application T-11676, and together with Certificate 89325, supersedes Certificate 79377, State Record of Water Right Certificates.
