CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOWER POWDER RIVER IRRIGATION DISTRICT  
2550 BROADWAY STREET  
BAKER CITY, OREGON 97814

confirms the right to use the waters of POWDER RIVER, tributary to SNAKE RIVER for IRRIGATION of 490.3 ACRES.

This right was perfected under Permit S-50622.

The date of priority is JUNE 1, 1987.

The amount of water to which this right is entitled is limited to 12.26 Cubic Feet per Second (CFS), or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located:

Basche Ditch: 1880 FEET NORTH AND 600 FEET EAST FROM S  $\frac{1}{4}$  CORNER, SECTION 28, being within the NW  $\frac{1}{4}$  SE  $\frac{1}{4}$  of Section 28, Township 7 South, Range 41 East, W.M.

Cranston Ditch: 880 FEET EAST FROM W  $\frac{1}{4}$  CORNER, SECTION 17, being within the SW  $\frac{1}{4}$  NW  $\frac{1}{4}$  of Section 17, Township 8 South, Range 42 East, W.M

Perkins Ditch: 50 FEET SOUTH AND 800 FEET EAST FROM W  $\frac{1}{4}$  CORNER, SECTION 17, being within the NW  $\frac{1}{4}$  SW  $\frac{1}{4}$  SECTION 17, Township 8 South, Range 42 East, W.M.

The amount of water used for irrigation together with the amount secured under any other prior right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre during the irrigation season of each year.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


