CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LHR, LTD 71105 HOLMES RD SISTERS, OR 97759

confirms the right to use the waters of A WELL in the DESCHUTES BASIN for SUPPLEMENTAL IRRIGATION OF 206.0 ACRES.

This right was perfected under Permit G-8672. The date of priority is SEPTEMBER 7, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.11 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the department, the water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

This certificate describes the water right confirmed by Certificate 76812, State Record of Water Right Certificates, and re-described in an order of the Water Resources Director entered MAR **0 6** 2015 approving Transfer Application T-11879.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
