## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WALKER RESERVOIR CONSTRUCTED UNDER PERMITS R-1407, R-1560 AND R-1761, A TRIBUTARY OF CHEHALEM CREEK, for IRRIGATION of 28.6 ACRES.

This right was perfected under Permit S-50741. The date of priority is APRIL 24, 1989. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 71.5 ACRE-FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.
