confirms the right to use the waters of UMATILLA RIVER, tributary of COLUMBIA RIVER for IRRIGATION of 4.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is DECEMBER 31, 1895.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.056 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

A description of the place of use is as follows:

When required by the Department, the water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The types and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to the provisions of paragraph 33 of said decree and all other conditions and limitations contained in said decree.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered OCTOBER 08, 2001, at Special Order Volume 55, Page 1077, approving Transfer Application 8554, and together with Certificate 77746, supersedes Certificate 29165, State Record of Water Right Certificates.
