CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON DEPARTMENT OF FISH AND WILDLIFE  
4034 FAIRVIEW INDUSTRIAL DR SE  
SALEM OR 97302

confirms the right to use the waters of ANA RIVER, A TRIBUTARY OF SUMMER LAKE for WILDLIFE ENHANCEMENT of 421.0 ACRES.

This right was perfected under Permit S-10447. The date of priority is OCTOBER 11, 1915. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 10.52 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion, and shall be used only during the irrigation season of each year.

The point of diversion is located as follows:

The amount of water used together with the amount secured under any other right exiting for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre during the irrigation season of each year. May 1 to September 30; provided further that, if the canal is kept in good maintenance and repair, the watermaster may allow not to exceed an additional 1 1/2 acre-feet per acre of water each season (maximum 631.5 acre-feet) to offset transmission losses, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install, maintain and operate a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.


When required by the Department, the water user shall install, maintain and operate an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to minimum flows established by the Water Policy Review Board with an effect date prior to this right.

This certificate is issued to confirm a CHANGE IN USE approved by an order of the Water Resources Director entered November 25, 1986, approving Transfer Application 5845, and together with Certificate 64860, supercedes Certificate 52562, State record of Water Right Certificates.
