CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BIG CREEK, tributary of the PACIFIC OCEAN, for MUNICIPAL USE.

This right was perfected under Permit S-19165. The date of priority is JUNE 8, 1945. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.3 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available from the original point of diversion described as follows:

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface water source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 25, 1998, at Special Order Volume 52, Page 234, approving Transfer Application 7865, supercedes Certificate 29022, State record of Water Right Certificates.
