 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MELVIN L LOVE  
 RT 1 BOX 358  
 FOREST GROVE, OR. 97116

confirms the right to use the waters of a RESERVOIR, tributary to UNNAMED STREAM for SUPPLEMENTAL IRRIGATION of 132.7 ACRES.

This right was perfected under Permit S-31937. The date of priority is MAY 25, 1966. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 14.20 ACRE FEET, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to a diversion of 2.5 acre feet for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


