 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MELVIN L. LOVE  
 RT 1 BOX 358  
 FOREST GROVE, OR 97116

confirms the right to use the waters of Drainage Ditch No.7 and Reservoir constructed under Application R-38709 and Permit R-3264 a tributary of North Fork Dairy Creek for IRRIGATION of 16.4 ACRES, and SUPPLEMENTAL IRRIGATION of 103.0 ACRES.

This right was perfected under Permit S-28825. The date of priority is MAY 6, 1963. The amount of water to which this right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed 0.20 CUBIC FOOT PER SECOND from Drainage Ditch No. 7 and 4.68 ACRE FEET from Reservoir, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
