## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

## NORTHSIDE APPLEGATE RIVER DITCH CO., INC. 9450 N APPLEGATE RD GRANTS PASS, OR 97526

confirms the right to use the waters of APPLEGATE RIVER and SLAGLE CREEK, tributaries of ROGUE RIVER for IRRIGATION of 31.27 ACRES AND SUPPLEMENTAL IRRIGATION OF 17.30 ACRES.

This right was perfected under Permit S-31981. The date of priority is SEPTEMBER 7, 1966. The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.217 CUBIC FEET PER SECOND, being 0.980 cfs from Applegate River and 0.237 cfs from Slagle Creek, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate describes that portion of the water right confirmed by Certificate 44830, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered March <u>30</u>, 2015, approving Transfer Application T-11915 and cancelling a portion of the water right.

This certificate is issued to correct a scrivener error on Certificate 44830, State Record of Water Right Certificates. Certificate 44830 incorrectly described the number of acres in the SW1/4 SE1/4 by transposing the number of acres of primary irrigation and the number of acres of supplemental irrigation.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
