confirms the right to use the waters of SIX WELLS in the OAK CREEK Basin for INDUSTRIAL USE AND EFFLUENT DILUTION.

This right was perfected under Permit G-11308. The date of priority is OCTOBER 30, 1990. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.25 CUBIC FEET PER SECOND (CFS), BEING 1.07 CFS FOR INDUSTRIAL USE AND 1.18 CFS FOR EFFLUANT DILUTION; FURTHER LIMITED TO 0.33 CFS FROM WELL #6, 0.49 CFS FROM WELL #7, 0.76 CFS FROM WELL #8, 0.22 CFS FROM WELL #10, 0.53 CFS FROM WELL #11, 0.27 CFS FROM WELL #12, IN ANY COMBINATION, or its equivalent in case of rotation, measured at the wells.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

This development was reviewed and approved by the Water Resources Commission on July 19, 1991.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a useable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the wells at all times.

The water user shall maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the headgates and measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall keep a complete record of the amount of ground water withdrawn.

The quantity of water diverted at the new points of appropriation (wells), together with that diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.

No water shall be used for effluent dilution except in compliance with the terms and conditions of any National Pollutant Discharge Elimination System (NPDES) waste discharge permit as issued by the Oregon Department of Environmental Quality. A copy of the NPDES permit is in Application File G-12277 at the Water Resources Department.

The use of water allowed herein for effluent dilution shall be subordinate to all subsequent water rights, except other rights issued specifically for effluent dilution.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water shall be limited when it interferes with any prior surface or ground water rights.
