## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of JOHN DAY RIVER, tributary of COLUMBIA RIVER, for IRRIGATION of 8.5 ACRES.

This right was perfected under Permit S-194. The date of priority is JANUARY 31, 1910. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.11 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

When required by the Department, the water user shall operate and maintain the headgate and measuring device, as needed. The water user shall report total flow figures when requested by the Watermaster. The Watermaster may operate the hedgate and monitor the accuracy of the measuring device, as needed.

Water shall be acquired from the same surface source as the original point of diversion.

The water user shall maintain a fish screen or fish by-pass device.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PARTIAL CANCELLATION OF A WATER RIGHT approved by an order of the Water Resources Director entered AUGUST 12, 2003, at Special Order Volume 57, Page 1295, approving Transfer Application 8832, and together with Certificate 80402, supercedes Certificate 412, State record of Water Right Certificates.
