## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEO GEKELER LA GRANDE, OR 97850

confirms the right to use the waters of the GRANDE RONDE RIVER and GEKELER SLOUGH, a tributary to the SNAKE RIVER for IRRIGATION of 119.28 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 227. The date of priority is 1883 for GRANDE RONDE RIVER and 1869 for GEKELER SLOUGH.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed, or its equivalent in case of rotation, measured at the points of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
