 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DAVID E WILSON
 O'BRIEN, OR

confirms the right to use the waters of **LITTLE ROCK CREEK**, a tributary of **WEST FORK ILLINOIS RIVER** for **IRRIGATION AND DOMESTIC USE FOR ONE FAMILY**.

This right was perfected under Permit S-17966. The date of priority is **SEPTEMBER 23, 1947**. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed **0.102 CUBIC FOOT PER SECOND**, being 0.092 c.f.s. for irrigation and 0.01 c.f.s for domestic use or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **ONE-FIFTIETH** of one cubic foot per second per acre, or its equivalent for each acre irrigated throughout the irrigation season from April 1st to November 1st of each year, and shall be still further limited to a diversion of not to exceed 0.102 c.f.s. and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Land on which water is to be used is a part of that described as follows:

Beginning at the initial point, which lies 2326 ft. South of and 1248 ft. East of the NW Corner of Sec. 26, T. 40 S., R. 9 W., W. M., in Josephine County, Oregon, which is the true point of beginning this description, running thence South 25° 04' East 410 ft. more or less to the intersection of the South line of the NW ¼ of Sec. 26, T. 40 S., R. 9 W., and the Westerly right-of-way line of the old stage road to Crescent City, Calif.; thence Southwesterly along the Westerly right-of-way line of said road to it's intersection with the South line of the NW ¼ of the SW ¼ of said section and range; thence west along said South line to the SW corner of NW ¼ of the SW ¼, said section, township and range to the West line of said Sec. 26; thence North along said West line of Sec. 26, to the NW


corner of Sec. 26; thence South 89° 40' East along the North line of said Sec. 26 to a point which lies North 3° 11' East from the point of beginning; thence South 3° 11' West 2047.9 feet to the point of beginning, containing 110.80 acres, more or less.

The right to the use of the water for the above purposes aforesaid is restricted to the lands or place of use herein described.

This certificate describes that portion of the water right confirmed by Certificate 20977, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAY 04 2015, approving Transfer Application T-11628.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
