CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GOLDEN RULE FARMS INC.

CHRISTMAS VALLEY OR 97641

confirms the right to use the waters of A WELL in the FORT ROCK BASIN, for IRRIGATION of 16.3 ACRES.

This right was perfected under Permit G-7011. The date of priority is OCTOBER 11, 1976. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.2 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

26 S	17 E	WM	34	SW NE	1323 FEET SOUTH AND 1340 FEET WEST FROM NE CORNER, SECTION 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

Twp	Rng	Mer	Sec	Q-Q	Acres
26 S	17 E	WM	34	SW NE	16.3

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW


This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered September 14, 2006, at Special Order Volume 70, Page 196, approving Transfer Application 9814, and together with Certificate 81515, supercedes Certificate 51592, State record of Water Right Certificates.
