## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

The STATE OF OREGON WATER RESOURCES DEPARTMENT

confirms the right to use the waters of WHYCHUS CREEK, a tributary of the DESCHUTES RIVER, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat, and other ecological values.

This right was confirmed by decree of the Circuit Court of the State of Oregon for CROOK COUNTY. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 1, at Pages 121, 122, 123, 124, 435, 438, 445, 472, and 473. The date of priority is 1895. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.43 cfs from April 1 to November 1, or such other time as Three Sisters Irrigation District is diverting water for a beneficial use under Certificate 74135.

The description of the stream reach in which flows are to be maintained is as follows:

From the location of the diversion previously authorized under Certificate 74135, located at approximately River Mile 23.5:

To the mouth of Whychus Creek, at River Mile 0.0.

Unless otherwise specified by a subsequent order establishing a new instream water right, the instream right established by this allocation of conserved water shall replace a portion of any instream water right established pursuant to ORS 537.341 or ORS 537.346 from the authorized point of diversion to River Mile 19.5, and shall be additive to any instream water rights established pursuant to ORS 537.341, 537.346, 537.348, or 537.470 from River Mile 19.5 to the mouth of Whychus Creek, unless otherwise specified by a subsequent order establishing a new instream water right.

This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume 95, Page 1001, Approving Allocation of Conserved Water Application CW-83, which modifies Certificate 74135, State Record of Water Rights.

The right is subject to all other terms and conditions of Certificate 74135, and any related decree.
